### Introduction

#### Project FREE to CODE

The project **FREE to CODE - 'Improving digital and coding skills for inmates'** - has the ambitious goal of using digital skills and computer programming as a means of human development that can help adult European prisoners to re-enter society with a resale expertise.

#### Background

In 2014, prisons across the EU were holding over half a million inmates, including both convicted persons, serving their final sentence, and persons accused of a crime. It is therefore a considerable number of people.

The European context in the management of education and social and educational rehabilitation of prisoners is quite rich. There are different experiences and educational programs tailored to allow a correct reintegration into society for incarcerated people, after having served the sentence imposed. Especially there are e-learning platforms established for such beneficiaries, as explained by the [Report on e-learning in European prisons](#).

But, since our society is facing a new digital era where new languages are raising up and whoever knows them can get more opportunities in finding jobs and help humanity to develop toward and beyond a

high-tech development, coding seems to be a great chance to learn and to be competitive, especially for those that could be starting from a weak and disadvantaged point.

Finally, there are not similar methods in this field, corresponding to what FREE to CODE proposes. In fact, some of previous funded projects on a similar topic (prisoners and reintegration) are more focused on general trainings on the topics, such as prison, reintegration, education, trainings to support social and labour market (re)integration of people in or after detention.

### The story so far



So far, the kick-off meeting has taken place in Bucharest in 8-9 November 2018. Partners met and explore the project objectives and overall strategy. Also during the kick-off meeting partners shared their views and strategies for the practical implementation of the project and especially the implementation of **Intellectual Output 1 - Best practices report on coding for detained learners** - methodology, tasks and responsibilities and deadlines was defined during those days.

To prepare the report, a survey proves to be necessary for two reasons:

1) the consortium aims to identify differences and specific needs of the target group, to consider any characteristic or divergence that may be relevant to the development of customised contents and tools;

2) to detect divergences between countries and common issues (including terminology) that may be relevant to a European audience of adult detained learners.

The focus of the survey will be on:

- general digital literacy level
- attitudes and perceptions about computer programming
- ideas on application of coding knowledge in finding a new job
- interest in being engaged in training activities
- common terminology in in the partners' countries
- preferred delivery methods and tools
